SAMPLE

Revenue/Income & Expense Report

We expect every applicant to provide revenue/income & expense reports for their project, even when it relies primarily on or exclusively on volunteer labor & in-kind donations. For donation-dependent projects, you must consider all non-cash sources for operating your project to calculate your yearly income & expense reports. **Here are some suggestions:**

REVENUE/INCOME

DONATED MATERIALS & SERVICES

This section estimates the value of non-cash donations such as volunteer labor or rent-free space. Even if you do not actually pay for these items, estimate the average cost on the current market. These items are considered both income and expenses since they are part of the operation of your organization.

Sample Line Items:

- Sisters' Labor
- Volunteer Labor
- Rent (rent-free room/ space)
- Food
- Medicine, etc.

CASH REVENUE/INCOME

This section itemizes all the sources of cash income that has been donated, granted or loaned to the project. It includes income-generating projects such as sale of crafts and poultry.

Sample Line Items:

- Congregation Subsidies
- Government Subsidies
- Foundation Grants
- Cash Donations/Contributions
- Sale of Products/Produce
- Bank Loans, etc.

EXPENSES

CASH EXPENSES

List the total annual costs of everything you must pay *in cash* to operate your organization.

Sample Line Items:

- Staff Salaries
- Rent
- Food
- Utilities
- Repairs & Maintenance
- Transportation Costs, etc.

BALANCE: Subtract total expenses from total income to see if you are operating at a net profit/surplus or a net loss/deficit. If you are operating at a net loss or deficit, please explain what corrective actions you will take. For example: help from congregation, fundraisers, reducing salaries, cutting cost of utilities, etc.
